CALL TO ORDER

The Omaha Public Library Board of Trustees met on Thursday, February 18, 2021 at the Millard Branch Library, 13214 Westwood Lane (Omaha). President Kennedy called the meeting to order at 5:05 P.M.

The President, or presiding officer, may use reasonable discretion to limit or extend a speaker's time to avoid redundancy, to assure a thorough public discussion on matters before the Board, and to end discussion.
